






The lack of library schools or other centers for archival education is a huge factor. Having worked in the Midwest and been active in MAC and several local archival organizations, I very much miss that level of participation but attending meetings here is no longer a question of a 1/2 hr. drive or a 90-minute train ride; such options do not exist here. While the Internet and email help, for a new resident of the CIMA region, neither provide an entree into the archival scene or allow a person to get to know colleagues or feel sufficiently comfortable to reach out and ask for advice or assistance.
